Dot VN, Inc. Announces .VN Domain Registration Increased 143% in <u>1st</u> Quarter 2007, and Engagement of 2 new Resellers

Currently, VNNIC manages over thirty eight thousand (38,000) domain names under registry. Dot VN reports a retention rate of over ninety five percent (95%) for domain names renewed by the registrants. Presently, Dot VN has over fifty (50) resellers outside of Vietnam and a total of over seventy (70) worldwide.
